



LIMITED WARRANTY

WOOD-SHIELD PTY LTD ACN 145 094 542 ("WoodShield") warrants to the purchaser ("You") named in the tax invoice provided with this document ("the Invoice") that the plastic coating ("the Coating") that has been applied to the posts sold pursuant to and described in the Invoice ("the Posts") will be free from material defects in workmanship and materials for a period of 10 years from the date of the invoice ("the Warranty Period").

This Limited Warranty is:

- (a) Personal to You;
- (b) Not transferable; and
- (c) Conditional upon registration of Your purchase, by You on WoodShield's website www.woodshield.com.au within 14 days of the date of the Invoice.

During the Warranty Period, to the extent that the Coating does not comply with this Limited Warranty, the Post that is the subject of that breach ("the Original Post") will be replaced at the option of WoodShield without charge to You for the cost of the new replacement post ("the Replacement Post").

The Warranty Period in relation to a Replacement Post will expire upon the later of 1 year after the Replacement Post is provided to You or 10 years from the date of the purchase of the Original Post.

This Limited Warranty does not cover:

- (a) damage arising from normal wear and tear;
- (b) the replacement of any posts damaged by misuse, proximity or exposure to heat, accident, abuse, neglect, misapplication or defects due to repairs or modifications made by anyone other than Wood-Shield;
- (c) physical damage to the surface of the Coating caused by trauma or impact of any kind;
- (d) damage arising from use of the Post in conjunction with other building materials or products, such as wire, not expressly approved or provided by Wood-Shield;
- (e) situations where it is determined by Wood-Shield that the malfunction of the Coating is not the fault of the workmanship or a material defect in the materials of the Coating itself;
- (f) damage arising from a failure by You to abide by the installation guide contained in the Information Sheet provided by Wood-Shield with the Post;
- (g) the breakage or fracture of the wooden component of the Post;
- (h) the failure of or any defect including but not limited to rotting or pest infestation in the wooden component of the Post;
- (i) the cost of removal of the Original Post or the installation of the Replacement Post.

Neither WoodShield nor the Distributor through whom You purchased the Post ("WoodShield's Distributor") is responsible for damage to any crops, stock or other assets owned by You or any other person as a result of the failure of the Coating or the Post.



The replacement of the Post as provided herein is the exclusive remedy provided to You.

You acknowledge and agree that the Posts are not sold to You for personal domestic or household use.

This Limited Warranty is in lieu of all other warranties expressed or implied, including any implied warranty of merchantability and/or fitness for a particular use or purpose and/or any implied warranty of non-infringement. Neither WoodShield nor WoodShield's Distributor shall be in any way liable to You for any damages You suffer or incur (including but not limited to general, special, consequential or incidental damages including damage for loss of business profits, or business interruption, and the like or personal injury or wrongful theft damages) arising from or in connection with the use or performance of the Posts even if WoodShield or WoodShield's Distributor are aware of the possibility of such damages.

In no event shall WoodShield's liability to You exceed the purchase price of the Post You purchased or the cost of a Replacement Post, whichever is greater.

To the extent that any legislation implies into this Limited Warranty, terms, conditions or warranties that cannot be excluded, such terms, conditions and warranties will apply to this Limited Warranty provided that WoodShield's liability for a breach of any such term, condition or warranty including for any economic or consequential loss shall be limited to the maximum extent permitted by law.

No claim will be accepted unless:

- (a) The purchase had been registered on WoodShield's website within 14 days of the date of the Invoice;

- (c) Evidence, satisfactory to WoodShield of the material defect in workmanship or materials of the Coating of the Posts is provided.
